Subject: Collation and publication of your VAT Registration Number

Dear Sir or Madam,

On the 13th July 2010 the EU Council Directive 2010/45/EU introduced changes to existing VAT invoicing rules. The UK was legally bound to introduce the necessary changes to UK VAT legislation by no later than 1st January 2013. Where a registered VAT supplier provides goods or services such as is mentioned in section 14(6) of the Act he shall provide that customer with an invoice in respect of that supply. Such an invoice provided under this regulation shall (a) comply with the requirements of regulations 13 and 14, and (b) bear the legend "VAT: EC ARTICLE 28 SIMPLIFICATION INVOICE". To simplify invoicing and billing processes within European markets the online database VAT-Reg-No.org was established. The publication of your corporate data in VAT-Reg-No.org is a voluntary, non-official, fee-based service which is offered from the Company Data S.P.R.L. Brussels. The publication will be for a minimum period of 24 months. The fee is £700,00 per annum and should be prepaid 14 days after the registration and invoicing. The order for registration will be extended by one year if its not cancelled in writing at least three months before the expiry of the contract. This contract shall be governed by the Laws of England & Wales. The specification of the VAT Registration Number on credit notes in the cases of reverse charges is also required under Section 2 of the Act.
